Application Fee (non-refundable): \$75.00 per new KH-8th grade student. This fee covers student assessments and new family processing costs. This fee is to be submitted along with application forms.

Registration Fee (non-refundable): \$150.00 per KH-8th grade student. This fee covers administrative costs for registration. This fee is due at the time of registration.

Material and Technology Fee (non-refundable): \$200 per KH-8th grade student. This fee covers curriculum, computer lab, paper, art supplies, testing materials, field trips/Middle School Retreat and background checks. This fee is due by July 1, 2010.

All tuition payments are due the 1st of the month.

- A \$35 late fee will be applied to accounts not current after the 1st day of each month (including NSF payments).
- All charges and fees other than tuition will be billed monthly and are due by cash or check the first of each month following the month the charges are incurred.
- Changes to enrollment agreements will result in a \$25 administrative fee charge.
- Please refer to additional terms and conditions on the Enrollment Contract.

Payment Options:

- Option 1: **Pay for the entire Academic Year** prior to August 1, 2010. Payments may be made by check, cash, Visa, MasterCard or American Express.
- Option 2: **Pay for the entire Academic Quarter** on or before the first business day of each Quarter (August, November, February, May). Payments may be made by check or cash.
- Option 3: **Quarterly Automated Tuition Payment (ACH)** authorizing tuition to be withdrawn from your account on the first business day of each Quarter (August, November, February, May). If you check this option, you will receive authorization forms that will require you to identify your bank account and authorize the withdrawals.
- Option 4: **Monthly Automated Tuition Payment (ACH)** authorizing tuition to be withdrawn from your account on the first business day of each calendar month beginning in August. Four academic quarters equal 11 monthly payments.
- Option 5: **Monthly payment by cash or check.** Tuition is due on the first business day of each calendar month beginning in August. Four academic quarters equal 11 monthly payments.

Extended Care Programs: Extended Care fees are billed monthly the month following the services. Each session has a one hour minimum charge of \$4.00 and is charged in one-half hour increments of \$2.20 each thereafter. All Day Extended Care charges are \$45 for 4 or more hours or \$30 for up to 4 hours. The charge for late pick-up is \$5 for the first five minutes after 6:00 pm. Thereafter, an additional \$1 will be charged per minute. After 6:30 pm, an additional \$50 will be charged. Charges are added to your monthly tuition bill at the end of each month. If tuition is not current, Extended Care privileges will be revoked. All fees are per student.

Sports and Other Fees: Fees for sports, class parties, special projects, etc. may be collected during the course of the school year.

Pastors: Full-time Pastors, who submit a letter at the time of registration from their Senior Pastor or an Elder confirming full-time pastoral ministry status, may receive a 30% tuition credit.

Referral Rebate: \$500 Tuition Credit! If you are a returning NCA family and you refer a new family to NCA (KH-8th Grade) you can receive up to a \$500 tuition credit (\$250 for families who have only KH students). This credit is applied to tuition after the new family has attended a full semester of school. The credit will appear on the February 2011 tuition statement. Referral Rebate Applications are available in the school office. Referral Rebates do not apply to families enrolling students in NCA's Pre-Kindergarten, Preschool or Early Learning Center.
